

# SECTION B: GENERAL TERMS

## $B-01 \rightarrow ACKNOWLEDGEMENT$

You acknowledge that you have thoroughly read and understood all the terms of this agreement. This document supersedes any prior agreements, whether oral or written, between Font Club Belgica and the Licensee. No changes to this agreement will be accepted unless expressly made in writing by Font Club Belgica.

Font Club Belgica reserves the right to modify or amend this agreement, or the End User

License Agreement (EULA), at any time and without prior notice.

# $B-02 \rightarrow IP OWNERSHIP$

You acknowledge that the Font Software, along with any other intellectual property or documents licensed under this EULA (Licensed IP), are the property of Font Club Belgica and their licensors. This EULA does not transfer ownership of any intellectual property rights to the Licensee. You acknowledge that you have no rights to the Licensed IP, except for the right to use them as permitted under this EULA.

You acknowledge that you do not have the right to access the Licensed IP provided under this EULA in source code form.

# B-O3 → NO LEASE, SUBLICENSING, ETC

The Licensee may NOT sell, lease, sublicense, or otherwise transfer or assign any rights, duties, or obligations under this agreement, in whole or in part, to any person or third party, including but not limited to, through a merger. Any breach of this provision will result in the immediate termination of the EULA, requiring you to delete all copies and destroy all materials (in any form, digital or physical) containing the materials or rights licensed under this EULA, including the Licensed IP.

Font Club Belgica licenses the Licensed IP for internal use by the Licensee's business only. The Licensee agrees not to use the Licensed IP for any resale purposes.

## $B-04 \rightarrow FEES$

Upon receipt of the full payment of the applicable license fee by Font Club Belgica, you will become a licensed user. The fees do not include any gross receipts, excise, import, export, value-added, or similar taxes. The Licensee is responsible for paying any applicable or additional fees and costs beyond the license fee.

## $B-05 \rightarrow NO$ MODIFICATIONS

Renaming, adapting, modifying characteristics, creating derivative works, reverse engineering, disassembling, decompiling, or altering the font format of the supplied variant or Licensed IP is strictly prohibited. You also agree not to transmit any electronic documents or software to any party intending to edit, transform, alter, enhance, merge, combine, or otherwise modify or remove the Licensed IP from any document. All modifications to the Licensed IP are strictly prohibited and may only be made by Font Club Belgica. Please contact Font Club Belgica directly to discuss any specific requirements.

# $B-06 \rightarrow REFUNDS$

Font Club Belgica does not provide refunds; all sales are final. Refunds may only be considered if the files are proven to be defective, following a thorough period of technical support and evaluation.

# B-07 → LICENSE NON-TRANSFERABLE

All licenses are non-transferable and are granted solely to the named Licensee upon entering into this EULA. You may not transfer or sublicense the license or the associated Licensed IP to any other parties, clients, affiliates, entities, or collaborators.

Any additional parties using the Licensed IP must obtain their own appropriate license before installing or using the Licensed IP.

# B-08 → A SINGULAR ORGANISATION

The license is granted for use by a single organization, entity, person, or individual. Multi-User

Licenses can be used across multiple locations, provided that all users are employed by the same organization, company, or entity.

The license is valid for only 1 (one) company, for example a Limited (LTD), Inc GmbH, PTY, PLC, CIA, Corp., LLC, S.A., ApS, ASA or equivalent recognised company title / suffix within your relevant jurisdiction.

# $B-09 \rightarrow VIRUSES$

While Font Club Belgica has taken reasonable measures to ensure that the Licensed IP is free from viruses or malware, Font Club Belgica accepts no responsibility for any damage to the user's hardware, software, or loss of income that may result. Installation of the Licensed IP is carried out at the Licensee's own risk, and Font Club Belgica will not be held liable for any such issues.

The Licensee acknowledges that the Licensed IP has not been developed to address the Licensee's specific needs or requirements, including but not limited to cybersecurity needs. It is the Licensee's responsibility to ensure that the Licensed IP meets their particular requirements.

The courts located in Belgium shall have exclusive jurisdiction to adjudicate any dispute or claim arising out of or relating to this agreement (including non-contractual disputes or claims). Each party hereby consents to the jurisdiction of such courts and agrees NOT to assert the defenses of lack of personal jurisdiction, improper venue or forum non conveniens in any such action brought under such court.

# $B-12 \rightarrow MAJOR BREACH OF LICENSE$

A material breach of any of these terms will entitle Font Club Belgica to terminate the EULA immediately upon notice. In such a case, Font Club Belgica will revoke the license for the Licensed IP without providing a refund. Following termination, you must destroy all copies of the Licensed IP, including backup or archival copies stored on external media (e.g., an external hard drive used for backups) including the materials in which the licensed IP was used, included and/or outlined.

If you continue to use the Licensed IP after receiving notice of termination, you will be required to pay a factor of the full license fees (in EURO € chosen at the discretion of Font Club Belgica) for its continued use on a per diem basis with compound interest.

You must pay the required sums within 7 (seven) days and provide any information requested by Font Club Belgica, including but not limited to Google Analytics data on page views per month, application (iOS, Android, and other platforms) downloads, and the number of users utilizing the Licensed IP on computers and/or devices.

# $B-13 \rightarrow MINOR BREACH OF LICENSE$

When purchasing a license for the Licensed IP, Font Club Belgica relies on the Licensee to accurately report their usage details (such as the number of computers on which the software is installed, page views per month, or application downloads) and to purchase the appropriate license based on their actual usage requirements.

Font Club Belgica may occasionally contact companies or brands that are suspected of exceeding the specified quotas. We reserve the right to do so as part of our commitment to safeguarding our intellectual property assets.

If it is determined that the Licensee has breached the usage quotas specified in their license, the Licensee agrees to rectify the breach by purchasing the appropriate license within 7 (seven) days of receiving written notice via email or post.

If the breach is not corrected, Font Club Belgica reserves the right to terminate the rights granted under this EULA. The Licensee will then be required to ensure that all materials (print, digital, application, broadcasting, physical) in their possession or control are destroyed within 14 (fourteen) days.

## $B-14 \rightarrow WARRANTY$

Font Club Belgica warrants that the Licensed IP will function correctly for 30 (thirty) days after purchase. This warranty does not apply if the defect results from unauthorized modifications by the Licensee or from a breach of this EULA by the Licensee.

While the Licensed IP is designed to ensure high compatibility with external software, Font Club Belgica cannot guarantee compliance or ongoing compatibility with external hardware and software from other manufacturers.

Font Club Belgica cannot guarantee that the Licensed IP is error-free and accepts no responsibility or liability for any errors in the Licensed IP licensed or distributed by Font Club Belgica. Please ensure that you are using the latest versions of our Licensed IP, downloaded from official channels.

## $B-16 \rightarrow VAT CVALUE ADDED TAXO$

Font Club Belgica, TypeMyType, and Studio Dries Wiewauters are VAT-registered in Belgium. If you are located in Belgium, the prevailing VAT rate will be applied to all applicable purchases. If you are within the European Union and provide a valid VAT number on our e-commerce platform or present it for manual invoicing and bank transfer, you can avoid the VAT charge. If you do not have a VAT number and are within the EU, the prevailing VAT rate for your location will be applied. For purchases made outside the EU, VAT will not be charged.

# $C-O1 \rightarrow LICENSE FOR BROADCASTING LOCATION$

Each Broadcast License permits the Licensee to use the Font Software in broadcasting applications such as video and moving images, publicly transmitted through screen-based media (e.g., digital signage screens, TV advertising, cinema advertising, hoardings, digital billboards). The license is based upon the company size and the number of continents where the Font Software will be broadcasted. Note that social media platforms (such as Instagram, YouTube, Pinterest, Twitter, and Vimeo) are excluded from this license; social media usage falls under the Desktop License.

For the purposes of this Agreement, "Company Size" refers to the total number of individuals employed by the Licensee, including all full-time, part-time, temporary, and contract employees across all departments and business functions. This includes, but is not limited to, employees in design, marketing, legal, accounting, production, human resources, sales, and administration.

"Company Size" also encompasses any affiliated entities, including subsidiaries, parent companies, and any other businesses under common ownership or control of the Licensee. # C-04 → SUPPLIED FILE FORMATS

The Font Software supplied in .OTF format may NOT be used to create bitmap, vector, or rasterized images in formats such as .JPG, .PNG, or .GIF, nor can it be embedded via the @font-face CSS rule on a website or web-based environment.

# $C-05 \rightarrow SUPPLIED FILE NAMING$

Broadcast Font Software is supplied in the following format: fontname-fontweight.xxx

The Licensee agrees NOT to alter this file naming structure. The naming schema uses kebab-case and CamelCase with each weight/style capitalized. The suffix should remain unchanged, and CamelCasing may only be removed if absolutely necessary.

Examples:

- FCNib-regularitalic.ttf
- FCNib-RegularItalic.ttf

# C-06 → FONT SOFTWARE PROTECTION

As a Licensee, you must take all reasonable measures to protect the Licensed Font Software from hotlinking, re-serving, or access by unlicensed parties, crawlers, or automated scripts.

# $C-07 \rightarrow PERPETUAL TERM$

The Broadcast License is perpetual. To remain valid, broadcast usage must stay within the licensed tiers.

# $\text{C-O8} \rightarrow \text{EMBEDDING}$ in any other software

Embedding the Licensed Font Software in other software or devices beyond the specified broadcasting applications is not permitted under this license and requires a separate license agreement based on the medium and usage.

# $C-09 \rightarrow FILE FORMATS$

The Broadcast License provides Font Software files in .OTF and variable .TTF formats (if selected during the licensing process). These files may not be converted or processed through any mechanism or software that alters or modifies their format (e.g., converting .OTF to web formats such as .WOFF, .WOFF2, .EOT, or .TTF).

The supplied .OTF and/or .TTF files may not be used for embedding or rendering live text via the @font-face CSS declaration, in web-based environments, or any other dynamic online software or programs.

# C-10 → FONT SOFTWARE PROTECTION

The Broadcast License is based on the number of employees as outlined in C-O1 and C-O2. If you exceed the specified number of employees within your purchased license, you must upgrade your license within 3 (three) working days. # SECTION D: DEFINITIONS

## $D-01 \rightarrow CAMEL CASING$

A typographical convention where the initial letter of the second element in a closed compound word is capitalized.

Example: CamelCasing

# $D-02 \rightarrow DOWNLOADS$

Unique individual requests to save an application incorporating Licensed Font Software to a device from a website or platform.

## $D-03 \rightarrow EMBEDDING$

The integration of Font Software within another software application.

Example: A web browser, an application.

## $D-04 \rightarrow END USER$

The individual who utilizes the Font Software.

# $D-05 \rightarrow EULA CEND USER$

## LICENSE AGREEMENTO

This End User

License Agreement.

# $D-06 \rightarrow EXTERNAL AFFILIATES / COMPANIES / AGENCIES$

All companies, agencies, individuals, entities, or external contractors that are not employees of the licensed company and are registered as separate entities not within the licensed company.

# $D-07 \rightarrow @FONT-FACE$

A CSS rule that allows Font Software to be downloaded from a web server to render a web page.

# D-08 → FONT SOFTWARE

Font Software refers to the software or instructions licensed under this EULA that, when used on an appropriate device or devices, generates typeface and typographic designs and ornaments. It includes the typeface, typographic designs, bitmap representations created by or derived from the Font Software, and all related upgrades, updates, modifications, copies, and documentation.

# $D-09 \rightarrow FOREX$

Also known as foreign exchange, FX, or currency trading, Forex is a decentralized global market where world currencies are traded.

# $D-10 \rightarrow KEBAB-CASING$

Text formatted in all lowercase with hyphens separating words.

Example: *looks-like-this* 

# $D-11 \rightarrow PAGE VIEWS$

A single instance of an Internet user visiting a particular page on a website.

## D-13 → PERPETUAL

Indefinite duration.

# $D-14 \rightarrow RASTERIZED FONT SOFTWARE$

The process of converting text from a vector format (such as TrueType or OpenType fonts) to a raster or bitmap format.

# $D-15 \rightarrow SUBDOMAIN$

An Internet domain that is part of a primary domain.

Example: http://beta.web.com

# $D-16 \rightarrow SELF-HOSTING$

The practice of uploading Font Software to a web server controlled by the licensing party to serve a website.

# D-17 → STANDARD C'STD') AND PROFESSIONAL C'PRO')

Abbreviations for our Standard ('STD') and Professional ('PRO') versions of Font Software. Details of the variations in content, features, and language support are available on our website.

## $D-18 \rightarrow TERMS$

This EULA is effective from the date both parties enter into the agreement and all fees have been paid, and will continue indefinitely unless terminated in accordance with the terms of this EULA.

## $D-19 \rightarrow TRANSACTION DATE$

The date on which a trade between Font Club Belgica and the Licensee occurs, and the financial amount is transferred to the nominated AS & EH Partnership bank account or e-commerce payment method. This date marks the official start of the license.

# $D-20 \rightarrow AUTHORIZED TOOLS$

Software programs developed, maintained, and distributed through official Font Club Belgica channels that may adapt, manipulate, modify, or change the font software from its full, complete versions.

# $D-21 \rightarrow OFFICIAL CHANNELS$

Any direct and certified delivery of Font Software by Font Club Belgica, including delivery from an authorized representative, via an @fontclubbelgica.com email address, or direct download from Font Club Belgica's websites and e-commerce stores.
